CALL FOR NOMINATIONS FOR RC46 AWARDS TO BE GIVEN AT THE 2018 WORLD CONGRESS

First, I would like to **thank all the board members** (including the officers) who are taking the time to be on the five award committees. We really appreciate your efforts! Second, we **encourage our members to nominate members for these awards.** (**Only members may nominate or be considered for awards.**) It does take time to put together a nomination package (all materials are submitted at one time), but it certainly is a nice tribute to honor another member. Please note that **each award has a separate award committee.** Make sure that a nomination package goes to the chair and the two members of the award committee dealing with the specific award. Third, the award committees can only consider the nomination packages that are submitted to them. All **nomination packages must be RECEIVED** by the members of the awards committees **no later than April 30, 2018.** Fourth, each award committee member and RC46 member submitting a nomination should **read closely the award guidelines** that are also attached here. For instance, the guidelines specify that preference will be given to publications that are about clinical sociology or explicitly link clinical sociology to a topic being discussed. Please think about this when developing your nomination package for one of the two publications awards.

I would like to underscore the importance of nomination letters and letters of support. They need to provide specifics. For instance, depending on the award, the specifics might be about the person; publication scope and impact; and/or the outcomes of the person's activities. Please remember that our members have many different languages and interests. For this award process to work, an award committee needs as much information as possible to help the committee make its decisions.

The RC46 of the International Sociological Association Lifetime Achievement Award in Clinical Sociology honors colleagues whose research and/or practice has significantly contributed to advances within clinical sociology. This award shall be a means of recognizing exceptional merit. The contribution should extend beyond the specialization in which the candidate has primarily worked and its scope should be widely recognized within the international clinical sociological community. The award will normally be awarded to scholars at an advanced stage in their careers, with distinguished records of multiple contributions throughout their careers. At the time of nomination and award, the person must be a member in good standing of the ISA and RC46. The award is a certificate (non-monetary award) and is presented at an official meeting of RC46. The recipient is invited to present a lecture at the time of presentation. The deadline for the receipt of nominations is set by the RC46 president.

COMMITTEE. The Lifetime Achievement Award in Clinical Sociology Committee is a Presidential Committee. It is composed of three members including and chaired by the RC46 President or her/his appointee. The two other members are appointed by the RC46 Executive Committee.
